# 4. Storage requirements

The packaged products shall be stored in clean, dark, non corrosive and well ventilated rooms with relative humidity no more than 80%. The transportation conditions shall be in accordance with the order contract, and shall be handled with care to prevent heavy pressure, direct sunlight and rain and snow.

## 5.Warning

- 5.1 Check whether the package is in good condition before use, confirm the package identification, production date and validity period and use them within the validity period.
- 5.2 This product is disposable and non-sterile, should be disposed as medical waste after use.

#### 7. Use method

Before using this product for disinfection, clean the surface of the device to ensure that the surface to be disinfected is free of stains. The area for disinfection should not be more than 19.5cm2 (area of non-woven). Tear open the package of small pieces, take out the non-woven pieces containing disinfectant with index finger and thumb, wipe and disinfect the solid surface of non-invasive medical devices that need to be cleaned 2-3 times, and make sure that the disinfectant solution on the product has completely covered the surface to be disinfected, and act for 5 minutes to achieve the disinfectant effect. After use, put the used alcohol disinfectant tablets into the appropriate trash.
